# **Customer Responsibility**

# **Collection of Delinquent Debts**

For outstanding balances, **Mach III Clutch** may make telephone calls and may send correspondence by facsimile, email, or post to the customer to provide information about delinquent balances and inquire about the payment of those balances, at our discretion. Non-receipt of such notifications does not excuse the customer from liability. Interest charges may be assessed on past due balances to the maximum rate allowed by law.

### **Cancellation of Credit Terms**

Mach III Clutch reserves the right to cancel credit terms for customers who allow balances to become past due and require payment by the alternate method of Mach III Clutch choice. Any customer with returned or stop payment checks will be required to remit the amount due by Cashier's Check prior to the shipment of any additional goods.
